Terms and Conditions

Your entry into Mozzigeat's Choose your Own Outdoor Family Adventure Competition (**the Competition**) is deemed acceptance of the following Terms and Conditions. Information on how to enter the Competition and the Prize(s) form part of these Terms and Conditions.

Who Can Enter

1. The Competition is open to Australian residents aged 18 years and over.
2. Employees and immediate families of Franbar Glen Pty Ltd (**the Promoter**) and associated agencies are not eligible to enter the Competition. Immediate family includes: spouse, ex-spouse, defacto spouse, child or step-child (including by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

4. 5. The Promoter reserves the right to verify the validity of any entry or individual entering the Competition at any time.

How to Enter

6. The Competition commences on 4 December 2018 at 09:00 AM AEDT and closes on 29 March 2019 at 18:00 PM AEDT (**the Competition Period**).
7. Entries must be received within the Competition Period.
8. To enter the Competition, eligible individuals must:
 - i) purchase an eligible product from the Mozzigeat product range (see website for eligible products and stockists) and retain their receipt as proof of purchase
 - ii) visit <https://www.mozzigeat.com.au/win> and complete the entry form
 - iii) upload a photo or scan of their receipt as proof of purchase
9. Entries that do not have an attached receipt as proof of purchase will not be eligible to win.
10. Multiple entries are permitted, subject to each entry being submitted separately and in accordance with these Terms and Conditions. One (1) unique receipt as proof of purchase is required per entry. Multiple entry using the same proof of purchase will not be accepted and will not be eligible to win.
11. Proof of purchase must be for eligible products purchased during the Competition Period.
12. Late, incomplete, indecipherable, discriminatory or otherwise offensive entries will be deemed invalid and may be disqualified.
